- Should this event need to be rescheduled for reasons beyond our control; you agree that you will not hold Middlesex County Craft Festival; Middlesex Shopping Extravaganza Events and its workers for any losses or revenue loss in case the event is shutdown for any reason and or cancelled.
- 2. All Buskers agree that they're performing to attendees for donations only.
- **3.** We will NOT hold spaces; you need to complete form and we send back. Confirmation of approval along with approved select date/time when be sent via email.
- 4. Signs, banners, or displays that are not integral to the performance are not permitted.
- 5. Buskers agree to provide their own professional/creative signage and provide their own table, chairs, tents, linens etc if needed.
- 6. All Buskers must have hand sanitizer present in area where payment/donation is taken.
- 7. Proper face coverings are required when NOT performing and where social distancing cannot be maintained 2 metres.
- **8.** You agree to allow Middlesex Shopping Extravaganza to list, market and take photos from your social media pages as well as photograph vendor/entertainment anytime during event and use for social media, website/marketing purposes.
